REQUESTS FOR OUR FREE CIVIL LEGAL SERVICES DURING THE LAST YEAR RESULTED IN HANDLING MORE THAN 10,933 CASES. IN 20 COUNTIES, CLOSE TO 235,000 PEOPLE ARE IN POVERTY AND ELIGIBLE FOR THE SERVICES OF NORTH PENN LEGAL SERVICES. WE PROVIDED CIVIL LEGAL AID TO 2,052 OF THOSE PEOPLE THROUGH COURT AND ADMINISTRATIVE HEARINGS, ENHANCING CLIENTS' ECONOMIC SECURITY BY OBTAINING AWARDS OF JUST OVER \$2.7 MILLION PRIMARILY IN CONSUMER CASES.
